Manchester Securities Corp. ("Manchester"), a wholly-owned subsidiary of Elliott Associates, L.P., entered into a Loan Agreement dated as of June 25, 2008 by and among Manchester, SemGroup Holdings, L.P. ("SG Holdings") and another party thereto (the "Loan Agreement"). After events of default with respect to SG Holdings occurred, Manchester, pursuant to its rights under the Loan

- (1) Agreement, obtained the right to direct the voting of all of the General Partner Units of the issuer and thereafter appointed,, inter alia, Sundar Srinivasan and David Bernfeld, who are employed by an affiliate of Manchester, to the Board of Directors of SemGroup Energy Partners G.P., L.L.C., the general partner of the issuer. Therefore, Manchester may be deemed to be a director of the general partner of the issuer by deputization.
- SG Holdings owns, and has pledged to Manchester and another lender under the Loan Agreement, its 12,570,504 Subordinated Units in the issuer and a 100% interest in the issuer's General Partner Units (consisting of 690,725 General Partner Units). As a result of the events of default with respect to SG Holdings, Manchester has a right to foreclose on 13/15 of such interests owned by SG Holdings. As of the date of this filing, Manchester has not foreclosed on these interests and has not decided to do so.
