Singer ("Singer"), Elliott Capital Advisors, L.P., a Delaware limited partnership ("Capital Advisors"), which is controlled by Singer, and Elliott Special GP, LLC, a Delaware limited liability company ("Special GP"), which is controlled by Singer, are the general partners of Elliott. Hambleton, Inc. ("Hambleton") is the general partner of Elliott International. International Advisors is the investment manager for Elliott International. International Advisors expressly disclaims equitable ownership of and pecuniary interest in any Common Stock.

Elliott Associates may be deemed to beneficially own 301,329 shares of Common Stock as Manchester Securities Corp., a wholly-owned subsidiary of Elliott Associates, is a pledgee of such shares of Common Stock in respect of certain defaulted loans. However, Elliott Associates will not, directly or indirectly through any of its subsidiaries, own of record at any time a number of shares of Common Stock in excess of 265,840 shares, which constitutes 2.99% of the outstanding Common Stock.

Elliott International and International Advisors together may be deemed to beneficially own 451,994 shares of Common Stock as Elliott International is a pledgee of such shares of Common Stock in respect of certain defaulted loans. However, Elliott International will not, directly or indirectly through any of its subsidiaries, own of record at any time a number of shares of Common Stock in excess of 265,840 shares, which constitutes 2.99% of the outstanding Common Stock.

Elliott Associates, Elliott International and International Advisors collectively may be deemed to beneficially own an aggregate of 753,323 shares of Common Stock.

(b) Percent of class:

Elliott Associates' deemed beneficial ownership of 301,329 shares of Common Stock constitutes 3.4% of all of the outstanding shares of Common Stock.

Elliott International's and International Advisors' deemed beneficial ownership of an aggregate of 451,994 shares of Common Stock constitutes 5.1% of all of the outstanding shares of Common Stock.

Elliott Associates', Elliott International's and International Advisors' deemed beneficial ownership of an aggregate of 753,323 shares of Common Stock constitutes 8.5% of all the outstanding shares of Common Stock.
