The Company's net sales for the three months ended December 31, 2009 are expected to be approximately \$25.0 million, as compared to net sales for the three months ended December 31, 2008 of approximately \$4.6 million. The increase is due principally to increased sales of our wireless broadband USB modems. The period ended December 31, 2009 also includes approximately \$600,000 of consolidated sales of Diffon Corporation, of which Franklin acquired slightly more than 50% in October 2009.
