Tara Gold Resources Corp. does not have any plans or proposals with respect to the matters listed in (a) through (j) below.

As of June 5, 2009 Tara Gold Resources beneficially owned 350,000 shares of the issuer's common stock. The shares beneficially owned by Tara Gold Resources represent 0.4% of the issuer's outstanding shares as of June 5, 2009.

As of June 5, 2009 Tara Gold Resources had the sole power to vote and to dispose of 350,000 shares of the issuer's common stock. These 350,000 shares represent 0.4% of the issuer's outstanding shares as of June 5, 2009.

On October 1, 2008 Tara Gold Resources Corp. sold mining properties to the issuer. The purchase price for the mining properties was 7,350,000 shares of the issuer's common stock.

On May 28, 2009 Tara Gold Resources agreed to transfer 900,000 shares of the issuer's common stock to an unrelated third party in settlement of \$650,000 owed to third party.

On May 29, 2009 Tara Gold Resources exchanged 1,500,000 shares of the issuer for 2,147,750 shares of the common stock of Tara Minerals Corp. The shares of Tara Minerals Corp. were held by nine persons who were not affiliated with Tara Gold Resources or Tara Minerals Corp. Tara Minerals

Corp. is a subsidiary of Tara Gold Resources.

On May 29, 2009 Tara Gold Resources sold 4,600,000 shares of the issuer's common stock to 26 unrelated persons at a price of \$1.07 per share.

The transactions described above were conducted privately and not through any exchange or public trading market.
