This Amendment No. 5 ( Amendment No. 5 ) amends and supplements the statement on Schedule 13D filed on March 4, 2016, and Amendment No. 1 filed with the SEC on April 20, 2016, and Amendment No. 2, filed on May 18, 2016, and Amendment No. 3, filed on February 27, 2017, and Amendment No. 4 filed on March 8, 2017. Together with this Amendment No. 5, Amendment No. 4, Amendment No. 3, Amendment No. 2, Amendment No. 1, and the Original Schedule 13D, with respect to the common stock, (the Shares ), of Franklin Limited Duration Income Trust (the Issuer ). Capitalized terms used herein and not otherwise defined in this Amendment No. 5 have the meanings set forth in the Original Schedule 13D, Amendment No. 1, Amendment No. 2, Amendment No. 3, and Amendment No. 4. This Amendment No. 5 amends Items 3 and 5 as set forth below.

**Item 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION**

Funds for the purchase of the Common Shares were derived from the subscription proceeds from investors in SCMF, SCMF II, SCLMF, SCS, SCEF 1 and SCEF 2 and the capital appreciation thereon and margin account borrowings made in the ordinary course of business. In such instances, the positions held in the margin accounts are pledged as collateral security for the repayment of debit balances in the account, which may exist from time to time. Since other securities are held in the margin accounts, it is not possible to determine the amounts, if any, of margin used to purchase the Common Shares reported herein. A total of \$21,540,985 was paid to acquire the Common Shares reported herein.

**Item 5. INTEREST IN SECURITIES OF THE ISSUER**
