Net income for the year ended May 31, 2010 is expected to be approximately \$503,000 compared to net income of \$912,401 for the year ended May 31, 2009.

Net income to common shareholders for the year ended May 31, 2010 is expected to be approximately \$98,000, or \$0.00 per share, compared to net income of \$481,727, or \$0.02 per share, for the year ended May 31, 2009.

The decrease in net income for the year ended May 31, 2010, when compared to net income for the year ended May 31, 2009, is primarily related to general increases in operating and general and administrative costs.
