The Company will not file the Form 10-K because it cannot complete the preparation of its consolidated financial statements without unreasonable effort and expense. The delay in the preparation of the consolidated financial statements resulted from the added work necessitated by the Company's merger with Great Lakes Chemical on July 1, 2005. The Company anticipates that it will file its Form 10-K prior to March 31, 2006.
