These delays relate to the Company s ongoing delay with respect to finalizing its financial statements for the year ended December 31, 2005. The financial statements for the year ended December 31, 2005 are currently in the process of being audited by the Company s independent registered accounting firm. The Company is unable to complete its financial statements relating to the quarter ended March 31, 2006 until its independent auditors have completed their audit of the Company s year-end financial statements, in light of the fact that adjustments resulting from the audit could potentially affect the presentation of the financial statements relating to the first quarter of 2006. These delays could not have been eliminated without unreasonable effort or expense. The Company expects to file the Form 10-Q after filing of its Form 10-K for the year ended December 31, 2006.
