GMH Communities Trust (the Company ) has experienced delays in finalizing its financial statements for the quarter ended September 30, 2006. These delays are due primarily to the fact that management required additional time to complete its review of the performance of applicable internal control processes and procedures associated with the preparation of its quarterly financial statements. As a result, the Company has been unable to complete its review the financial statements relating to its third quarter ended September 30, 2006 by the requisite filing date. These delays could not have been eliminated without unreasonable effort or expense.
