This Amendment No. 9 to Schedule 13D hereby amends the Schedule 13D Amendment No. 8 filed on March 2, 2006. The filing of this Schedule 13D is not, and should not be, an admission that such Schedule 13D is required to be filed.

(a) The aggregate number of securities to which this Schedule 13D relates is 17,152,729 shares (the Securities ), representing 21.8% of the outstanding 78,626,564 shares of the Issuer's Class A common stock (assuming the Issuer's Class U common stock, but not the Issuer's Class B common stock, are converted) as of December 31, 2006. All of the Securities are shares of Class U common stock of the Issuer that are mandatorily converted into shares of Class A common stock of the Issuer in connection with any transfer by the Reporting Persons to a third party that is not an affiliate of Univision. The conversion ratio is 1:1. The Securities represent approximately 14.8% of the Issuer's Class A common stock assuming conversion of the Class B common stock and Class U common stock and the exercise of all outstanding options and restricted stock units as of December 31, 2006.

(b) The Reporting Person has sole power to vote or direct the vote and sole power to dispose or to direct the disposition of the Securities reported for it.

(c) To the best of its knowledge, the Reporting Person has not effected any transaction in the Securities during the past sixty days.

(d) Not applicable.

(e) Mr. A. J. Perenchio has, in the past, disclaimed beneficial ownership of the Securities held by Univision Communications Inc ( UCI ). As of the effective date of the merger under the merger agreement among UCI, Umbrella Holdings, LLC and Umbrella Acquisition, Inc., Mr. Perenchio disposed of all of his holdings of UCI stock and therefore cannot be deemed to have beneficial ownership of the Securities held by UCI.
