### **Item 8.01 Other Events.**

On March 21, 2008, the board of directors of Ebix, Inc. (Ebix or the Company) ratified an increase in the Company sability to repurchase its own current outstanding shares of common stock from an aggregate of \$1 million (\$1,000,000) to \$5 million (\$5,000,000). Under the terms of the board sauthorization, Ebix retains the right to purchase up to \$5 million (\$5,000,000) in shares but does not have to repurchase this entire amount. All repurchases are expected to be funded from existing cash.
