EXPLANATORY STATEMENT

This Amendment No. 1 to Schedule 13D (Amendment) relates to the Common Stock, \$1.00 par value per share (the Common Stock) of Ecolab Inc. (the Issuer). This Amendment is begin jointly filed by Cascade Investment, L.L.C. (Cascade), Bill & Melinda Gates Foundation Trust (the Trust), William H. Gates III and Melinda French Gates (collectively, the Reporting Persons), to amend and supplement the Items set forth below of the Reporting Persons Schedule 13D previously filed with the Securities and Exchange Commission on July 29, 2011. Neither the present filing nor anything contained herein shall be construed as an admission that the Reporting Persons constitute a group for any purpose and the Reporting Persons expressly disclaim membership in a group.

Item 3. Source and Amount of Funds or Other Consideration

During the period August 22 through August 23, 2011, Cascade purchased 2,530,900 shares of Common Stock with its working capital for an aggregate purchase price of \$120,799,751.25.

Item 5. Interest in Securities of the Issuer

(a) See items 11 and 13 of the cover pages to this Schedule 13D for the aggregate number of shares and percentage of Common Stock beneficially owned by each of the Reporting Persons.

(c) Since the filing of the last Schedule 13D, Cascade purchased 2,530,900 shares of Common Stock for cash in open market transactions on the dates and for the weighted-average purchase prices set forth in Exhibit 99.1, which is attached hereto and incorporated by reference.

(d) Except as set forth in this Schedule 13D, to the knowledge of the Reporting Persons, no person has the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, securities covered by this Schedule 13D.
