In addition, pursuant to Rule 416(a) under the Securities Act of 1933, as amended (the Securities Act), this Registration Statement also registers such additional shares of Common Stock as may be offered or issued under the Plan to prevent dilution from stock splits, stock dividends, or similar transactions which results in an increase in the number of the outstanding shares of Common Stock or shares issuable pursuant to awards granted under the Plan.

(2) Estimated solely for purposes of calculating the amount of the registration fee, pursuant to Rules 457(c) and 457(h) of the Securities Act, based on the average of the high and low sales prices of the Common Stock as reported on the NASDAQ on September 9, 2014.

EXPLANATORY NOTE

This registration statement on Form S-8 (this Registration Statement) is filed by Take-Two Interactive Software, Inc. (the Company or Registrant), to register an additional 5,000,000 shares of the Registrant's common stock, par value \$0.01 per share (the Common Stock), which may be issued under the Take-Two Interactive Software, Inc. 2009 Stock Incentive Plan (the Plan), which was amended and restated on July 23, 2014, to, among other things, increase the number of shares of Common Stock reserved for issuance thereunder, which amendment and restatement has been approved by the Registrant's stockholders.

Pursuant to the Registration Statement on Form S-8 (Registration No. 333-191993) filed by the Registrant on October 30, 2013, the Registration Statement on Form S-8 (Registration No. 333-177822) filed by the Registrant on November 8, 2011, and the Registration Statement on Form S-8 (Registration No. 333-158735) filed by the Registrant on April 23, 2009 (together, the Prior Registration Statements), the Registrant previously registered an aggregate of 22,208,954 shares of Common Stock (as adjusted to reflect all stock splits and stock dividends to date). The additional shares of Common Stock being registered by this Registration Statement are of the same class as those securities registered on the Prior Registration Statements and represent an increase in the total shares available for issuance under the Plan from 22,208,954 to 27,208,954. The contents of the Prior Registration Statements, together with all exhibits filed therewith or incorporated therein by reference to the extent not otherwise amended or superseded by the contents hereof or otherwise, are incorporated herein by reference in accordance with General Instruction E to Form S-8.
