**EXPLANATORY NOTE**

This Amendment No. 1 to the Schedule 13D amends and supplements the Schedule 13D, filed July 18, 2014 (the "Schedule 13D"), by the Filing Persons (as defined below) relating to the Common Stock, par value \$0.0001 per share, of Minerva Neurosciences, Inc., a Delaware corporation (the "Issuer"). The Issuer is filing this amendment to the Schedule 13D solely to update the disclosures set forth therein to include the open market transactions discussed in Item 3 below.

**Item 3. Source and Amount of Funds or Other Consideration**

Item 3 is hereby amended to add the following:

From January 6, 2015 through January 8, 2015, Care Capital Investments III L.P. sold 523,073 shares of Issuer's Common Stock and Care Capital Offshore Investments III LP sold 8,735 shares of Issuer's Common Stock in open market transactions.

**Item 5. Interest in Securities of the Issuer**

Item 5 is hereby amended and restated as follows:

(a) As of January 16, 2015, Care Capital Investments III L.P. is the beneficial owner of 3,296,355 shares of the Issuer's Common Stock, representing 17.9%% of the Issuer's shares of Common Stock outstanding (based upon 18,439,482 shares of Common Stock outstanding, as reported in the Issuer's Quarterly Report on Form 10-Q for the quarter ended September 30, 2014 filed on November 5, 2014). As of January 16, 2015, Care Capital Offshore Investments III LP is the beneficial owner of 55,049 shares of the Issuer's Common Stock, representing 0.3% of the Issuer's shares of Common Stock outstanding (based upon 18,439,482 shares of Common Stock outstanding, as reported in the Issuer's Quarterly Report on Form 10-Q for the quarter ended September 30, 2014 filed on November 5, 2014). By virtue of Care Capital III LLC's status as general partner of Care Capital Investments III L.P. and Care Capital Offshore Investments III LP, Care Capital III LLC may be deemed the beneficial owner of 3,351,404 shares of the Issuer's Common Stock held by Care Capital Investments III L.P. and Care Capital Offshore Investments III LP, representing 18.2% of the Issuer's shares of Common Stock outstanding (based upon 18,439,482 shares of Common Stock outstanding, as reported in the Issuer's Quarterly Report on Form 10-Q for the quarter ended September 30, 2014 filed on November 5, 2014). Care Capital III LLC disclaims beneficial ownership of the securities, and this report shall not be deemed an admission that Care Capital III LLC is the beneficial owner of such securities for purposes of Section 16 or for any other purpose, except to the extent of their pecuniary interest therein.

(b) By virtue of its status as general partner of Care Capital Investments III L.P. and Care Capital Offshore Investments III LP, Care Capital III LLC may be deemed to share voting and dispositive power with respect to the 3,296,355 shares of Issuer's Common Stock held by Care Capital Investments III L.P. and 55,049 shares of Issuer's Common Stock held by Care Capital Offshore Investments III LP. Care Capital III LLC disclaims

beneficial ownership of the securities and this report shall not be deemed an admission that Care Capital III LLC is the beneficial owner of such securities for purposes of Section 16 or for any other purpose, except to the extent of their pecuniary interest therein.
