**Item 1.01. Entry into a Material Definitive Agreement.**

On August 18, 2015, United Therapeutics Corporation (the *Company*) entered into an Asset Purchase Agreement (the *Agreement*) with AbbVie Ireland Unlimited Company (*AbbVie*), a wholly-owned subsidiary of AbbVie Inc. Pursuant to the Agreement, the Company agreed to sell to AbbVie its Rare Pediatric Disease Priority Review Voucher (*PPRV*), which was awarded to the Company by the U.S. Food and Drug Administration in connection with the approval of Unituxin™ (dinutuximab) for the treatment of neuroblastoma, a rare pediatric disease. Upon closing, AbbVie will pay the Company \$350,000,000 in cash in consideration for the PPRV. Closing of the transaction is subject to customary conditions, including the expiration or termination of the required waiting period under the Hart-Scott-Rodino Antitrust Improvements Act of 1976. The Agreement contains customary representations, warranties and covenants.

The foregoing summary is qualified in its entirety by the full text of the Agreement, a copy of which is attached hereto as Exhibit 2.1 and incorporated herein by reference.
