DEREGISTRATION OF UNSOLD SECURITIES

This Post-Effective Amendment is being filed to deregister unsold securities of PHH Corporation, a Maryland corporation (<u>PHH</u> or the <u>Registrant</u>), that were registered on Registration Statement on Form S-3ASR (No. 333-208672) (the <u>Registration Statement</u>) filed with the U.S. Securities and Exchange Commission on December 21, 2015, pertaining to the registration of an unspecified number of shares of common stock, par value \$0.01 per share (<u>Common Stock</u>), shares of preferred stock, par value \$0.01 per share, (<u>Preferred S</u>tock), debt securities, an unspecified number of warrants for the purchase of Common Stock, Preferred Stock, or debt securities, and an unspecified number of units consisting of some or all of these securities in any combination.

On October 4, 2018, pursuant to the Agreement and Plan of Merger, dated as of February 27, 2018 (the <u>Merger Agreement</u>), by and among Ocwen Financial Corporation (<u>Ocwe</u>n), POMS Corp (<u>Merger Sub</u>), and PHH, Merger Sub merged with and into PHH (the Merger), with PHH surviving the Merger as a wholly owned subsidiary of Ocwen.

In connection with the Merger, the Registrant has terminated all offerings of its securities pursuant to the Registration Statements. Accordingly, the Registrant hereby terminates the effectiveness of the Registration Statements and, in accordance with undertakings contained in the Registration Statements to remove from registration by means of a post-effective amendment any of the securities that had been registered but remained unsold at the termination of the offering, removes from registration any and all securities of the Registrant registered but unsold under the Registration Statements as of the date hereof.
