Explanation of Responses:

The Google Stock Units ("GSUs") entitle person to one share of Class A Common Stock as GSUs vest. The GSUs vest as follows:
 - (1) 1/48th vests on the 25th calendar day of the month following the vesting start date and an additional 1/48th vests monthly on the 25th day of each month thereafter, subject to continued service on such vesting dates. Vesting start date is July 11, 2012.
 - (2) Vesting of Google Stock Units grant of which was previously reported in Form 4.
 - (3) The GSUs vest as follows: 1/48th of GSUs shall vest on the 25th day of the first month after the vesting start date and an additional 1/48th will vest monthly thereafter, subject to continued service on such vesting dates. Vesting start date is July 6, 2011.
 - (4) The GSUs vest as follows: 1/4th vests 12 months after the vesting start date and 1/16th vests each quarter thereafter, subject to continued service on such vesting dates. Vesting start date is June 2, 2010.
 - (5) Each share of Class A Common Stock was issued upon the conversion of one share of Class B Common Stock at the election of Reporting Person.
The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$878.66 to \$879.65, inclusive. The Reporting Person undertakes to provide to any security holder of Google Inc. or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the ranges set forth in footnotes (6) through (14) to this Form 4.
 - (6) These shares were sold in multiple transactions at prices ranging from \$879.93 to \$880.92.
 - (7) These shares were sold in multiple transactions at prices ranging from \$881.29 to \$882.28.
 - (8) These shares were sold in multiple transactions at prices ranging from \$882.57 to \$883.56.
 - (9) These shares were sold in multiple transactions at prices ranging from \$883.75 to \$884.74.

 - (15) There is no exercisable date for the Issuer's Class B Common Stock.
