 - (5) On March 5, 2015, the reporting person was granted 148,365 restricted stock units, vesting in three equal annual installments beginning on the first anniversary of the grant date.
 - (6) On March 6, 2014, the reporting person was granted 76,530 restricted stock units, vesting in three equal annual installments beginning on the first anniversary of the grant date.
