The reporting person hereby undertakes to provide upon request to the SEC, the Issuer or a security holder of the Issuer the number of common shares of beneficial interest and the prices at which the transactions were effected.
  - (5) The reported amount consists of 6,925 restricted stock units. The restricted stock units are to be settled in an equal number of shares of Class A Common Stock upon vesting.
