- (1) The options acquired by Mr. Hulley were issued pursuant to that certain Retirement Agreement and Release by and between the Company and Mr. Hulley dated February 13, 2006. Under the terms of the Retirement Agreement and Release, Mr. Hulley was entitled to receive the above options because 75,000 of the previously issued 100,000 options granted to Mr. Hulley on June 21, 2004 expired unissued on January 2, 2008. Mr. Hulley previously exercised 25,000 of the 100,000 options on June 29, 2007. Consequently, the options above represent 75% of the number of options that Mr. Hulley would have been issued pursuant to the terms of the Retirement Agreement and Release had he not exercised 25,000 of the previously issued 100,000 options.
