 - (1) On January 4, 2010, the Issuer entered into an agreement with George H.C. Lawrence (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 950 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").

This figure includes 4,350 restricted shares of Class A Common Stock issued pursuant to the Restricted Stock Award Plan. On January 3, 2010, restrictions applicable to a previously reported grant of 800 shares of Class A Common Stock lapsed, resulting in the Reporting Person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.
 - (2) The Reporting Person is the direct beneficial owner of 41,612 shares of Class A Common Stock, including the 4,350 restricted shares referenced in Footnote (2). He is the indirect beneficial owner of 2,600 shares of Class A Common Stock owned of record by the George H.C. Lawrence Money Purchase Plan, of which the Reporting Person is the sole trustee.
