Partnership Units have no expiration date.
- (2) Upon termination of the Neil Shah 2009 GRAT, 235,513 Partnership Units were transferred by the trust to the Neil and Juhi Shah 2008 Family Trust and continue to be reported in this Form 5 as being indirectly owned.
