The securities were purchased by the Reporting Person from Peter E. Salas, Chairman of the Board of the Company (218,000) shares; Jeffrey R. Bailey, Chief Executive Officer and a Director of the Company (500,000 shares); Cary V. Sorensen, Vice-President, General Counsel and Secretary of the Company (200,000 shares); and Dolphin Offshore Partners, L.P., which prior to the purchase was the largest (1) shareholder of the Company. Peter E. Salas is the sole shareholder and controlling person of Dolphin Mgmt. Services, Inc., the managing general partner of Dolphin Offshore Partners, L.P. (15,458,321 shares) (hereinafter, Messrs. Salas, Bailey, and Sorensen and Dolphin Offshore Partners, L.P. are referred to collectively as the "Sellers"). The Sellers are the sole members of the Reporting Person, SSB Ventures LLC. Each of the Sellers retains the power to direct the voting by SSB Ventures LLC of the shares that each of the Sellers re
