Effective July 20, 2005, Mr. Najeeb Ghauri resigned from the position of Chief Financial Officer for NetSol Technologies, Inc. (the "Company" or "NetSol") retaining his position as Chairman of the Board. Mr. Ghauri was replaced by Ms. Tina Gilger effective June 20, 2005. Ms. Gilger has acted as a consultant to the Company of the past two years in the capacity of controller. Ms. Gilger's services with the Company included, but were not limited to, preparing the accounting records for auditor review and audit and provided assistance with the preparation of the Company's quarterly and annual reports. Ms. Gilger has fifteen years of accounting experience including work for both audit and accounting firms. to 2002, Ms. Gilger acted as audit liaison for Newbridge Capital, a public company specializing in reverse mergers for public companies listed on the OTC:BB. The material terms of Ms. Gilger's employment arrangement with NetSol include: salary of \$84,000 per annum; the grant of options to purchase 10,000 shares of common stock of the Company at the exercise price of \$1.86; and, the grant of options to purchase 10,000 shares of common stock of the Company at the exercise price of \$2.79.
