- (4) 973 shares of common stock of the Issuer previously received by the reporting person upon the vesting of RSUs. The transfer was made without consideration. See Note 1.

These shares are held of record by OrbiMed Private Investments IV, LP ("OPI IV"). OrbiMed Capital GP IV LLC ("GP IV") is the general partner of OPI IV and Advisors is the managing member of GP IV LLC. Samuel D. Isaly ("Isaly") is the managing member of and owner of a controlling interest in Advisors and may be deemed to have voting and investment power over the shares held by OPI IV.

- (5) The reporting person is a member of Advisors.
