(the "Partnership"), that closed on May 23, 2005, Sunoco Partners LLC, the Partnership's general partner, sold 2,500,000 common units to the Partnership and such units were redeemed by the Partnership at a price of \$35.906 per common unit, representing the net proceeds received by the Partnership for a like number of common units sold in the public offering. Sunoco Partners LLC is a Pennsylvania limited liability company with the following members: Sun Pipe Line Company (67%); Sunoco, Inc. (R&M) (13%); and Atlantic Refining & Marketing Corp. (20%).
