(3) EXPLANATION OF CHANGE

The Registrant's total revenues were \$1,188,045 in the fiscal year ended December 31, 2006, versus \$178,821 in fiscal 2005. The increase in total revenues resulted from the integration of businesses acquired by the Registrant February and March of 2005.

The Registrant's net loss available to common stockholders was approximately \$8.7 million, or \$(1.19) per share, for the fiscal year ended December 31, 2006, compared to a net loss of \$44.45 million, or \$22.78 per share, for the prior year.
