ITEM 4. REGISTRANT EXTENDS EXPIRATION OF RIGHTS OFFERING TO APRIL 4, 2003.

On October 1, 2002, Intelli-Check, Inc. (the "Company") extended until April 4, 2003 all unexercised rights under its rights offering which are due to expire on October 4, 2002. This determination was approved by the Company's Board of Directors.

Each non-transferable right entitles the stockholder to purchase one share of common stock at an exercise price of \$8.50.

Under terms of the original offering, the Company declared a dividend distribution of one non-transferable right to purchase one share of its common stock for every 10 outstanding shares of common stock held of record on March 30, 2001, and continuously held until exercised at an exercise price of \$8.50.

The Company currently has the right to redeem the outstanding rights for \$0.01 per right upon 30 days notice to the holder.
