Mr. Yehuda Saban has a deep understanding of the telecommunications field from his term as Manager of the Telecommunications and Tourism Unit in the Budgets Department of the Ministry of Finance, from where he retired in September 2011 and as an active partner in the Hayek Committee that dealt with formulating a policy in the fixed line field.
