Units are redeemable for an equal number of shares of the issuer's Common Stock or, at the election of the issuer, cash equal to the fair market value of such shares. The issuer elected to redeem the reporting person's Units with Common Stock. Units have no expiration date.
  - (2) Includes 398 shares acquired as part of the Company's quarterly dividend paid on March 22, 2010.
  - (3) 3,446 shares are also held indirectly by the reporting person through the Company's 401(k) Plan.
