As previously reported, on 01/15/09 the reporting person was granted 16,410 restricted stock units ("RSUs"), 8,205 of which vested on 01/15/10, and 8,205 of which will vest on 01/15/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 14.5996 dividend equivalent rights at \$44.96 per RSU credited to the reporting person's account on 07/07/10, and 16.1119 dividend equivalent rights at \$40.74 per RSU credited to the reporting person's account on 10/06/10.
- (4) As previously reported, on 12/10/09 the Reporting Person was granted 12,040 restricted stock units ("RSUs"), 6,020 of which will vest on 12/10/10 and 12/10/11.
