- (1) The total beneficial ownership includes 496,275 shares at \$13.1575 per share acquired under the HP 2011 Employee Stock Ownership Plan ("ESPP") on 10/31/12 with respect to shares held under the ESPP.
 - (2) This option will vest 50% on the second anniversary of the grant date and 50% on the third anniversary of the grant date, in both cases subject to the satisfaction of certain stock price performance conditions prior to the fourth anniversary of the grant date.
 - (3) Each restricted stock unit represents a contingent right to receive one share of HP common stock.
 On 12/06/12 the reporting person was granted 65,076 restricted stock units ("RSUs"), 21,692 of which will vest on each of 12/06/13, 12/06/14, and 12/06/15. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
