(1) There is no reportable change since the last filing. This is a reiteration of holdings only.

(2) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

(3) As previously reported, on 12/14/11 the reporting person was granted 159,212 restricted stock units ("RSUs"), 53,070 of which vested on 12/14/12, and 53,071 of which will vest on each of 12/14/13 and 12/14/14. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 932.8059 dividend equivalent rights being reported reflect 932.8059 dividend equivalent rights at \$15.02 per RSU credited to the reporting person's account on 01/02/13.

(4) On 03/20/13 the reporting person was granted 3,616 restricted stock units ("RSUs"), 1,205 of which will vest on each of 03/20/14 and 03/20/15, and 1,206 of which will vest on 03/20/13. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
