- (1) Grant of stock under the Issuer's 2011 Equity Incentive Plan, as amended, in connection with the Reporting Person's services as a Director.  
The aggregate value of the annual equity award to each director in 2018-2019 was set at \$220,000, with one quarter, or \$55,000, to be granted on the first day of each quarter, based on the closing price of the Issuer's common stock on such day. The closing price of the Issuer's common stock on April 1, 2019, the first day of the quarter, was \$144.70. Mr. Fedak's term as a Director ends on May 8, 2019, and he is not standing for re-election; thus, his quarterly grant was prorated accordingly.
- (3) Represents the closing price of the Issuer's common stock on April 1, 2019.
