- (2) The options to purchase common stock vest 20% each year on the anniversary date of the Option to Purchase grant date. Thus 20% vested on October 19, 2006 and an additional 20% shall vest on each of October 19, 2007, October 19, 2008, October 19, 2009 and October 19, 2010.

- (3) Reflects adjustment to previously granted stock option awards under the Domino's Pizza, Inc. 2004 Equity Incentive Plan in connection with the special dividend of \$13.50 per share of Common Stock of Domino's Pizza, Inc. payable on May 4, 2007 to shareholders of record on April 27, 2007. The exercise price of the stock options was adjusted by the amount of the dividend, or by such lesser amount as required by law, in accordance with the Dividend Equivalent Rights Policy of Domino's Pizza, Inc.

- (4) Total holdings of shares acquired through Employee Stock Payroll deduction plan includes, 892,858 acquired between July 29, 2006 and May 8, 2007.

- (5) Total holdings in the Domino's Pizza stock fund, part of the Domino's Pizza 401(k) savings plan, acquired between January 1, 2007 and May 8, 2007.
