(1) 60,000 stock options with an exercise price of \$24.00 were granted on February 17, 2000 and vest in annual installments of 20%, 20%, 30% and 30%, beginning on the first anniversary of the grant date.

(2) 120,000 stock options with an exercise price of \$12.44 were granted on November 1, 2000. These options vest in two installments of 25% each on the first and second anniversary of the grant date, and in eight subsequent quarterly installments of 6.25% each, commencing on February 2, 2003 and ending on November 1, 2004.

(3) 40,000 stock options with an exercise price of \$9.625 were granted on April 4, 2001. These options vest in two installments of 25% each on the first and second anniversary of the grant date, and in eight subsequent quarterly installments of 6.25% each, commencing on July 5, 2003 and ending on April 4, 2005.

(4) 247,500 restricted stock units were granted on March 16, 2009. These restricted stock units are performance based and will vest based on the achievement of certain performance goals of the Company over a three-year period from October 1, 2008 to September 30, 2011.
