(1) Represents performance shares (restricted stock units) that will be converted on a one-for-one basis into shares of Applied Materials, Inc. common stock upon vesting. These performance shares will vest only after the satisfaction of specified performance goals. Provided such goals are achieved, vesting is scheduled to occur no earlier than in four equal annual installments beginning 12/19/2011 (subject to continued employment through each vest date).

(2) Increased number of shares reflects periodic payroll acquisitions under Employees' Stock Purchase Plan that are exempt under Rule 16a-10 and Rule 16b-3. Number of shares also includes 385,625 performance shares (restricted stock units) previously reported that in the future will be converted on a one-for-one basis into shares of Applied Materials, Inc. common stock upon vesting, which vesting is scheduled to occur as follows: (a) 39,375 shares are scheduled to vest in two equal annual installments beginning 12/19/10; (b) 86,563 shares are scheduled to vest on 12/19/2010; (c) 30,000 shares are scheduled to vest on 12/19/2011; (Continued in Footnote 3)

(3) (d) provided specified performance goals are achieved, 109,687 shares are scheduled to vest on 12/19/11; and (c) provided specified performance goals are achieved, 120,000 shares are scheduled to vest: (i) as to 20,000 shares no earlier than 12/19/2011 and (ii) as to 100,000 shares no earlier than in two equal annual installments beginning 12/19/2012 (all vesting is subject to continued employment through each vest date).
