- (1) This amount reflects the previous transfer of 18,953 shares of common stock to Mr. Pfeiffer's ex-wife pursuant to a domestic relations order (DRO). Mr. Pfeiffer no longer reports such shares as beneficially owned. Of the 110,438 shares of common stock shown in Table I, Box 5, Mr. Pfeiffer's ex-wife is entitled to 15,794 restricted shares of common stock, which will be transferred to his ex-wife upon vesting pursuant to the DRO, and over which he disclaims any beneficial ownership or pecuniary interest.
