- (3) Mr. Snyder transferred 475,400 shares of FactSet Common Stock to The Charles J. Snyder 2011 Grantor Retained Annuity Trust, of which Mr. Snyder is the sole trustee. He will have complete authority in connection with the shares held by the trust.
- (4) Mr. Snyder transferred 122,998 shares of FactSet Common Stock from The Charles J. Snyder 2008 Grantor Retained Annuity Trust to The Charles J. Snyder 2008 Family Trust, of which Susan J. Snyder is the sole trustee. He will maintain indirect beneficial ownership of the shares held by Family trust.
