The reporting person is a participant in the Atlas Pipeline Partners, L.P. (the "Partnership") 2004 Long-Term Incentive Plan (the "2004 Plan"). The reporting person received 500 phantom units under the 2004 Plan on May 10, 2009 and 500 phantom units under the 2004 Plan on May 10, 2010. The reporting person is also a participant in the Atlas Pipeline Partners, L.P. 2010 Long Term Incentive Plan (the

(1) "2010 Plan") and received 1,823 phantom units under the 2010 Plan on May 10, 2011, and 1,503 phantom units under the 2010 Plan on May 10, 2012. Each phantom unit represents the right to receive, upon vesting, either one common unit of limited partner interest of the Partnership or its then fair market value in cash; the phantom units vest 25% per year. With respect to the vestings that occurred on May 10, 2013, the reporting person elected to receive cash in lieu of common units for 625 units.

(2) The reporting person received 1,971 phantom units under the the 2010 Plan on May 10, 2013.
