- (1) Pursuant to the Agreement and Plan of Merger by and among Nielsen Holdings N.V. ("Nielsen"), TNC Sub I Corporation and Arbitron Inc., as amended (the "Merger Agreement"), 10,786.6499 of these restricted stock units were cancelled in exchange for a cash payment equal to \$48.00 per share and 2,006 of these restricted stock units were converted into restricted stock units with respect to 2,651 shares of Nielsen common stock.
- (2) Pursuant to the Merger Agreement, the options, which provided for vesting in three equal annual installments beginning on the first anniversary of the date of grant, were canceled in exchange for a cash payment representing the difference between \$48.00 per share and the exercise price.
