**ITEM 8.01 OTHER EVENTS**

On April 18, 2005, DIMON Incorporated issued a press release announcing that, as part of its previously announced (1) cash tender offer for any and all of its outstanding (a) 9<sup>5</sup>/<sub>8</sub>% Senior Notes due 2011 (the 9<sup>5</sup>/<sub>8</sub>% Notes ) and (b) 7<sup>1</sup>/<sub>4</sub>% Senior Notes due 2013 (the 7<sup>1</sup>/<sub>4</sub>% Notes ) and, collectively with the 9<sup>5</sup>/<sub>8</sub>% Notes, the Notes ), and (2) solicitation of consents to amend each of the indentures governing the Notes, it is extending the expiration date of the tender offer.
