Item 1.01 Entry into a Material Definitive Agreement.

On August 2, 2005, Dynegey Inc. (Dynegey) and certain of its subsidiaries entered into a definitive purchase agreement for the sale of Dynegey s Midstream natural gas business to Targa Resources, Inc., a Houston, Texas based company (Targa), and certain of its subsidiaries. Under the terms of the purchase agreement, which has been approved by the boards of both companies, Targa will acquire Dynegey s ownership interests in Dynegey Midstream Services, Limited Partnership, which holds Dynegey s natural gas gathering and processing assets, as well as its natural gas liquids fractionation, terminalling, storage, transportation, distribution and marketing assets.

Dynegey expects to receive \$2.475 billion in cash, subject to working capital adjustments, of which \$2.35 billion will be paid at closing. In addition to the amount payable at closing, based on current expectations, Dynegey will realize a return of cash collateral of \$125 million and eliminate its responsibility for approximately \$75 million in letters of credit for the Midstream business, both within 60 days of the transaction closing.

The completion of the transaction is conditioned upon the expiration or termination of the Hart-Scott-Rodino waiting period and the fulfillment of other closing conditions as set forth in the purchase agreement. Pending satisfaction of those conditions, the sale is expected to close in the fourth quarter 2005. The proceeds from the Midstream transaction will be used to reduce outstanding debt to the extent required by Dynegey s debt covenants. In accordance with Financial Accounting Standard No. 144, results associated with Dynegey s Midstream natural gas business will be reclassified to discontinued operations.

The foregoing description of the purchase agreement and the transactions contemplated thereby does not purport to be complete and is qualified in its entirety by reference to the purchase agreement, which Dynegey intends to file as an exhibit to its quarterly report on Form 10-Q for the period ended September 30, 2005.
