Attached is an English translation of the summary of the letter dated March 29, 2007 filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated March 29, 2007, the Company reported that a holder of the Company's Convertible Notes exercised his conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 2,001,814 while a capital increase of 3,942,130 common shares of face value pesos 1 each has been completed. The conversion was performed according to the terms and conditions established in the prospectus at the conversion rate of 1.96928 shares, face value pesos 1 per Convertible Note of face value US\$ 1.

As a result of the above referred conversion, the number of outstanding shares of the Company is increased from 264,970,691 to 268,912,821. Therefore, the amount of registered Convertible Notes is US\$ 3,067,911.
