By letter dated November 8, 2007, the Company reported that on November 7, a holder of Company s Convertible Notes exercised its warrant rights. Hence, a reduction of 581,395 warrants and an increase of 1,066,779 ordinary shares face value pesos 1 (V\$N 1) each was made. As a result, the amount of shares of the Company goes from 574,638,809 to 575,705,588. The new amount of warrants outstanding is 919,524. The exercise of the warrant was performed according to terms and conditions established in the prospectus of issuance. The amount of shares acquired is equal to the amount of shares into which it was converted the convertible note at a price of US\$ 0.6541 for each share face value pesos 1. Therefore US\$ 697,780.14 entered into the Company.
