**Item 7.01 Regulation FD Disclosure.**

On December 6, 2007, Newmont Mining Corporation, a Delaware corporation ( "Newmont" ), and Miramar Mining Corporation, a British Columbia corporation ( "Miramar" ), issued a press release announcing the extension of the offer (the "Offer" ) of Newmont Mining B.C. Limited, a wholly-owned indirect subsidiary of Newmont ( "Acquisition Sub" ), to purchase at a price of C\$6.25 in cash per common share all of the issued and outstanding common shares of Miramar (other than common shares owned directly or indirectly by Newmont, and including common shares that may become issued and outstanding after the date of the Offer but before the expiration of the Offer) from 5:00 p.m. (Toronto time) on December 6, 2007 to 5:00 p.m. (Toronto time) on December 21, 2007. The Offer is being extended to accommodate satisfaction of a condition of the Offer that requires approval of the acquisition under the Investment Canada Act that has not yet been satisfied. The initial review period under the Investment Canada Act will expire on December 13, 2007.
