Item 1.01 Entry into a Material Definitive Agreement

On September 27, 2009, Covidien plc (the Company), through its subsidiaries, entered into a definitive agreement to acquire Aspect Medical Systems, Inc. (Aspect), a global market leader in brain monitoring technology.

The Boards of Directors of both the Company and Aspect have unanimously approved the transaction, pursuant to which a wholly owned subsidiary of the Company will pay \$12.00 in cash per Aspect share for a total of approximately \$210 million, net of cash and short-term investments acquired. The transaction, which will take the form of an all cash tender offer followed by a second-step merger, is subject to customary closing conditions, including receipt of certain regulatory approvals, and is expected to be completed by the end of calendar 2009.

A copy of the Agreement and Plan of Merger is furnished as Exhibit 2.1 to this Current Report and incorporated herein by reference. The Agreement and Plan of Merger has been attached as an exhibit to provide investors and security holders with information regarding its terms. It is not intended to provide any other factual information about the Company or Aspect. The representations, warranties and covenants contained in the Agreement and Plan of Merger were made only for the purposes of such agreement and as of specified dates, were solely for the benefit of the parties to such agreement, and may be subject to limitations agreed upon by the contracting parties and may be subject to standards of materiality applicable to the contracting parties that differ from those applicable to investors. In addition, the assertions embodied in the representations and warranties contained in the Agreement and Plan of Merger are qualified by information in a confidential disclosure schedule that the parties have exchanged, which has been omitted pursuant to Item 601(b)(2) of Regulation S-K. Accordingly, investors should not rely on the representations and warranties as characterizations of the actual state of facts.

Item 7.01 Regulation FD Disclosure

On September 28, 2009, the Company issued a press release announcing entry into a definitive agreement to acquire Aspect. A copy of the press release is furnished as Exhibit 99.1 to this Current Report and incorporated herein by reference.

Important Additional Information Will Be Filed with the Securities and Exchange Commission (SEC)

This current report is neither an offer to purchase nor a solicitation of an offer to sell shares of Aspect. Transformer Delaware Corp. (the Merger Sub), an indirect, wholly-owned subsidiary of the Company, has not commenced the tender offer for the shares of Aspect stock described in this current report.

Upon commencement of the tender offer, the Merger Sub will file with the SEC a tender offer statement on Schedule TO and related exhibits, including the offer to purchase, letter of transmittal, and other related documents. Following commencement of the tender offer, Aspect will file with the SEC a tender offer solicitation/recommendation statement on Schedule 14D-9. These documents will contain important information about the Company, Aspect, the transaction and other related matters. Investors and security holders are urged to read each of these documents carefully when they are available.
