**Mumbai**, August 14, 2013: The Tata Motors Group global wholesales in July 2013, including Jaguar Land Rover, were 87,566 nos. Cumulative wholesales for the fiscal were 335,067 nos.

Global wholesales of all commercial vehicles -Tata, Tata Daewoo and the Tata Hispano Carrocera range -- were 40,882 nos. Cumulative commercial vehicles wholesales for the fiscal were 161,088 nos.

Global wholesales of all passenger vehicles in July 2013 were 46,684 nos. Cumulative passenger vehicles wholesales for the fiscal were 173,979 nos.
