### Item 8.01 Other Events.

On May 31, 2011, Exelon Corporation (Exelon) and Constellation Energy Group, Inc. (Constellation) filed the notification and report forms required under the Hart-Scott-Rodino Antitrust Improvements Act of 1976 in connection with the proposed transaction announced by Exelon and Constellation on April 28, 2011. On June 30, 2011, Exelon and Constellation each received a Request for Additional Information and Documentary Material from the Antitrust Division of U.S. Department of Justice (DOJ). This request is generally consistent with Exelon's expectations regarding the scope of DOJ's review of the proposed transaction.
