**ChipMOS REPORTS AUGUST 2011 REVENUE; REITERATES 3Q11 OUTLOOK**

**Hsinchu, Taiwan, September 16, 2011** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (Nasdaq: IMOS) today reported its unaudited consolidated revenue for the month of August 2011. The Company today also reiterated its prior outlook for the third quarter of 2011 for revenue to be flat-to-down in the single digits as compared to the second quarter of 2011, while maintaining gross margin on a consolidated basis in the range of 4.0% to 9.0%.

Revenue for the month of August 2011 was NT\$1,474.1 million or US\$50.8 million, an increase of 3.3% from the month of July 2011 and a decrease of 9.1% from the same period in 2010. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$28.99 against US\$1.00 as of August 31, 2011.)
